# Meeting Minutes February 10, 2009 Redwood Empire Association of Code Officials Cattlemen's Steakhouse 5012 Petaluma Boulevard North Petaluma

# 1. Call to Order

President Steve Pantazes (Town of Windsor) called the meeting to order at 12:00pm at the Cattlemen's Steakhouse, Petaluma.

It was noted that we-REACO membership should try to use people from our membership as trainers in order to be more cost conscious and still get the necessary training. Dave noted that \$850 went to donations. Mike Enright explained historically who REACO donates money to and that it was up to the current membership to determine if money would be donated this year.

c. Vice President Glenn Schainblatt reported on his attendance to 2009 CALBO. The motion was seconded and carried unanimously.

Mike Whitaker addressed the pressure from local concerns to provide a standard requirement for roof mounted photovoltaic systems. The South Bay area has come up with a policy. The Santa Rosa Guidelines do not contain the State Fire Marshall's suggestions. It was recommended for committee to meet and come up with the approved standard. See AB 811.

Mike also noted that he thinks that the state will soon be requiring energy audits on existing home resale.
